BACKGROUND:

Due to the restructuring of the gas franchise agreement with Ameren, the City is now eligible to take advantage of purchasing natural gas from certified gas suppliers much in the same way that large-volume consumers such as industries, universities, and agri-business have for many years.

Good Energy, the City’s current electric aggregation consultant, will be opening competitive gas supply and purchase bids on March 6th, 2019 for commencement on May 1st, 2019. The contract must be signed on the day of bid opening (March 6, 2019).

A representative from Good Energy will be present to provide the Council with information and also available to answer any of your questions. Good Energy anticipates the City of Monticello witnessing a natural gas savings of 15%-20%.

RECOMMENDED ACTION:

It is recommended that the City Council discuss and approve Resolution 2019-18 thus approving the Mayor or City Administrator to enter into an agreement on behalf of the City of Monticello with the awarded natural gas supplier.

RESOLUTION 2019-18
A Resolution to Accept a Natural Gas Supply Agreement
For Purchase of Natural Gas for Municipal (City) Accounts

WHEREAS, Good Energy, L.P., serves as agent and consultant for the City of Monticello with regard to purchasing utility supply (electric and natural gas supply) for the City of Monticello in the performance of its municipal responsibilities; and

WHEREAS, Good Energy, L.P., has previously acted and continues to act as the broker for the supply portion of electric and natural gas supply; and

WHEREAS, Good Energy, L.P., electric and natural gas supply is a commodity and prices change daily and to capture the best rates must be acted on within a minimal timeframe; and

WHEREAS, Good Energy, L.P., has expert knowledge and awareness of such prices and has previously worked with other numerous municipalities; and

WHEREAS, Good Energy, L.P., has negotiated the best utility rates and terms for electrical and natural gas supplies for the City of Monticello.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Monticello, that the Mayor or City Administrator are hereby authorized and directed to execute on behalf of the City a Natural Gas Supply Agreement with a supplier for **gas supply for City accounts** as recommended by Good Energy L.P. as long as substantial savings are realized.
